## President's Message



Dear Friends.

It is an honor to serve as the President of the Public Lands Foundation (PLF). While Courtney Lyons-Garcia, our part-time Executive Director, has done amazing work for the organization, PLF remains principally an engine that is fueled by the passion and efforts of volunteer members at all levels. I am constantly amazed at and grateful for the quality and quantity of the work accomplished to further our BLM and public lands advocacy mission.

PLF again met virtually in 2021 as the country was still dealing with the impacts of the global pandemic. Since there would be no cost to travel to an in-person meeting, Past President Ed Shepard asked the Board to instead contribute to the George Lea scholarship fund. The Board members came through and PLF was again able to award two scholarships in both 2021 and 2022.

In 2022, PLF engaged with the BLM in a variety of ways. PLF and the BLM renewed our Memorandum of Understanding (MOU) in January during our first meeting with BLM Director Tracy Stone-Manning. PLF then hosted two receptions on behalf of the BLM, one in Washington, D.C., and one in Casper, Wyoming. PLF is partnering with the BLM on a History Project which will involve digitizing vital records in the PLF Glendon E. Collins Archive located at the BLM National Training Center in Phoenix, Arizona. The PLF also met virtually during the year with BLM Leadership to strengthen ties.

PLF continues advocating on behalf of the BLM and public lands. We submitted testimony on BLM's FY 2023 Appropriations to the House Appropriations Subcommittee and the Senate Subcommittee on Interior, Environment, and Related Agencies Committee on Appropriations. We have collaborated with other organizations such as the National Association of Forest Service Retirees (NAFSR), American Wildlife Conservation Partners (AWCP) and Society of American Foresters (SAF) on public lands issues. Additionally, PLF revised its suite of Position Statements which are posted on the website.

After a three-year pause, the PLF was finally able to meet in person in Grand Junction, Colorado, from September 20-23. The theme was managing e-bike use and while the weather derailed our field trip, the District and Field Office staffs pivoted beautifully and provided great information indoors. There were many excellent presentations, including one by the BLM Director. At the banquet, PLF presented its annual awards and provided an outstanding opportunity for members to connect in person once again. The Planning Committee consisting of Beau McClure, Bob Moore, Tom Allen, Maggie Wyatt and Eric Janes did a fantastic job on the meeting and deserve our thanks for their herculean efforts.

The fifth Biennial Student Congress was held October 3-6 in Boise, Idaho. The event is now known as The John Freemuth Student Congress to memorialize the contributions of Dr. Freemuth to public policy and public lands management. In addition, PLF partnered with both the NAFSR and the Andrus Center for Public Policy to host the Congress. As with all previous iterations, the Student Congress was a tremendous success.

Finally, the PLF celebrated its 35th birthday in 2022 while its founder, George Lea, celebrated his 95th birthday. Both milestones are laudable. For the PLF to continue into its next 35 years, it is vitally important that we grow both our financial and membership bases. The work of the Development Committee and the Membership Committee has been designed to do exactly that. We applaud their efforts, but it is up to each of us to assist with this important task.

### 2022: A Return to In-Person Events

As PLF helped the BLM celebrate its 75th year, COVID restrictions began to be lifted and in-person events resumed. This included two events that PLF hosted and trips to Washington DC to work on projects with the BLM and our partners.

In January PLF President Mary Jo Rugwell, Past President Ed Shepard and Executive Director Courtney Lyons-Garcia met with BLM Director Tracy Stone-Manning and her staff in Washington DC. A new Memorandum of Understanding was signed between the BLM and PLF continuing our long history of collaboration for the betterment of our public lands.

In March PLF hosted a reception for the 75th anniversary of the BLM in Washington DC. Congressman Lowenthal of California gave remarks, as did our board president Mary Jo Rugwell and BLM Director Tracy Stone-Manning. PLF founder George Lea was in attendance at this celebratory evening. This was also the public debut of the new Foundation for America's Public Lands and their four founding board members were in attendance. President Rugwell and Executive Director Lyons-Garcia addressed the new board at their first meeting regarding PLF and potential partnerships between the two organizations.

In May PLF hosted its final reception of the 75th anniversary celebrations at the National Historic Trails Interpretive Center in Casper, Wyoming, as part of the Outdoor Writers Association of America annual conference. This evening was highlighted by remarks from BLM Director Tracy Stone-Manning and the celebration went long into the evening.

PLF is proud to have been a central resource for the BLM and host for events during the 75th anniversary. We greatly appreciate the resources provided by our sponsors for the celebrations.

## Advocacy

The PLF works year-round on advocacy outreach activities. We pursue this advocacy mission by remaining current on public land issues and policies, prepare Position Statements, and communicate our concerns and recommendations to the BLM, Congress, stakeholder interest groups and the general public, and respond to media inquiries. We testify before Congress and submit written testimony on budget, legislation, and policy matters affecting the BLM and the public lands. The PLF prepared an Advocacy brochure to support our Advocacy outreach efforts in 2023 and 2024. Priority Advocacy issues included Rebuilding the BLM, Public Land Access, Public Land Recreation, Special Areas Management, and Renewable Energy.

### **FY 2023 BLM BUDGET**

The PLF provided written testimony on the BLM Fiscal Year 2023 proposed budget to both the Senate and House Subcommittees on Interior, Environment, and Related Agencies. Testimony included recommendations for additional funding to rebuild the BLM after the failures and loss of significant staff from the BLM headquarters reorganization effort in 2019 and 2020, funding to support the sustainable and balanced development of both traditional and renewable energy resources and associated infrastructure development on the public lands, funding to support collaborative sagebrush habitat restoration projects, sustained funding to support the BLM wild horse and burro management plan, funding for wildland fire suppression and landscape health and resiliency projects, increased funding in the Recreation program to respond to the dramatic increase in the recreational use of the public lands, and funding to support the work of the newly established Foundation for America's Public Lands on behalf of the BLM. The PLF also requested additional supplemental funds in the BLM Rangeland Management program to address the ever-increasing backlog of grazing permit renewals on the public lands.

### **OIL AND GAS LEASING REFORM**

The PLF continued to track actions by the Department of the Interior and the BLM during 2022 to implement federal oil and gas leasing

reforms as outlined in a Department report released in 2021. The PLF updated an Oil and Gas Leasing Position Statement that outlined recommendations on additional reforms in the oil and gas leasing program, issued a News Release on our recommendations, and provided a letter to Secretary Haaland and BLM Director Stone-Manning on our recommendations.

### **SOLAR AND WIND ENERGY**

The PLF provided comments to the BLM on proposed guidance to reduce rental rates for solar and wind energy authorizations on the public lands and also updated a Position Statement that outlined recommendations for facilitating renewable energy development on the public lands. The BLM later announced the decision to reduce the acreage rent and megawatt capacity fee for solar and wind energy authorizations on the public lands, announced the signing of an interagency MOU to improve Federal agency coordination, and announced the decision to reestablish Renewable Energy Coordination Offices to facilitate and streamline the permitting process.

### **PUBLIC LAND ACCESS**

The PLF supported passage of P.L. 117-114, the Modernizing Access to Our Public Lands Act (MAPLand Act), by Congress in 2022 and updated a Public Land Access Position Statement that provides additional recommendations for addressing public land access issues in the west. The PLF is closely tracking a court case in Wyoming that involves public land access to checkerboard lands.

### **MINING LAW REFORM**

The PLF updated a Position Statement on Mining Law Reform and provided recommendations for amendments to the 1872 Mining Law in response to a request from the Department for public comments. In addition, the PLF participated in roundtable discussions during 2022 with an Interagency Working Group on Mining Law Reform. The PLF also provided supplemental comments on the hardrock abandoned mine lands (AML) program in response to a Department request for comments.

## Student Congress

2022 marked the return of the John Freemuth Student Congress. This year's Congress was presented by a partnership between PLF, the National Association of Forest Service Retirees and the Andrus Center for Public Policy at Boise State University. The theme for this year's Congress was Wildland Fire and attracted the most applicants ever for the 25 spots.

We are pleased to note that this year's Congress was the most diverse to date and brought in students from every corner of the country.

The students spent a week on the Boise State campus discussing Wildland Fire, its implications for local communities and next steps for the BLM and USFS to take in addressing the issue. The Congress was divided into four work groups that tackled a specific topic and then presented their findings at the end of the week.

The group spent a morning at the National Interagency Fire Center where they received a tour and were greeted by Grant Beebe, the National Interagency Fire Director. After learning about NIFC operations the students broke into two groups to take tours of local public lands and learn about on the ground fire management.

The week ended with each of the groups making their recommendation presentations to BLM Idaho Director Karen Kelleher, Grant Beebe and others at NIFC. A group of the students took these recommendations and distilled them into a report which will be presented to BLM and USFS staff in Washington DC in Spring 2023.


## Financials

The Public Lands Foundation is financially sound with total assets over \$411,000 as of the end of 2022. PLF relies primarily on individual membership dues and directed program contributions for income. PLF raised more than \$60,000 for the 2022 Student Congress and \$36,000 for the 75th Anniversary celebrations for the BLM. These two events were the main income streams over the last two fiscal years in addition to a planned gift that was received in 2021.

2022 saw a major dip in the market and PLF's investments were negatively impacted, as was the rest of the country. In addition, our two campaigns saw income and expenditures spread over two fiscal years, creating a negative balance for 2022 despite our strong income stream in 2021. Despite the market losses PLF was able to bring in steady contributions to its Scholarship and Student Congress funds. We are confident that our organization is healthy and recovered from the COVID impact.

We will continue to raise funds for the 2024 Student Congress, our George Lea Founders Scholarship, the BLM History Program and our new advocacy campaign.
